

# European Equity Multi-Manager Fund

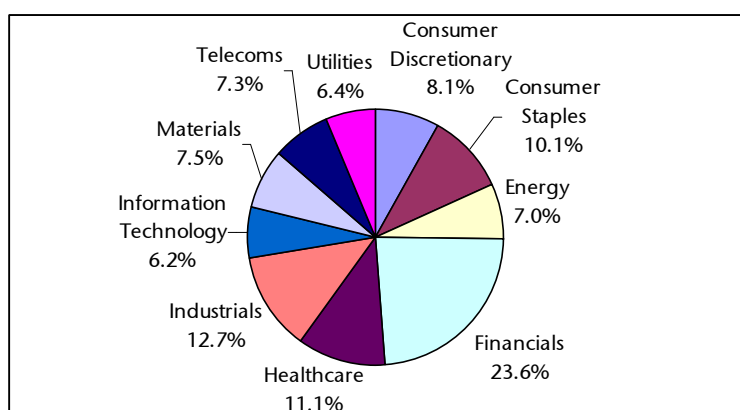
