

# Global Equity Multi-Manager Fund

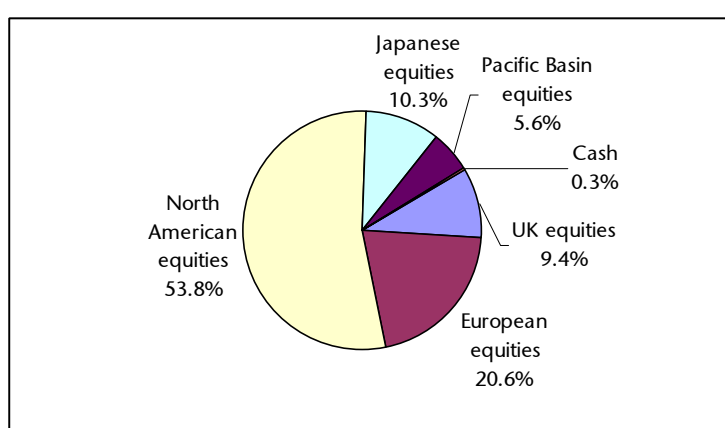
